THE UNION'S PUBLIC FORUM

Editor The Union: Among bills introduced at the last moment by the assembly, I find that Assembly Bill 2525, introduced by Sheridan and Dickey, assemblyman of Alameda County, would, if it became a law take away from San Diego the Cabrillo statue and permanently move it to Oakland.

The legislature of California --- not the governor, according to an opinion from the attorney general, has the final say as to its permanent location. As matters stand today we have the statue in our possession and the senate of California unanimously passed my bill two years ago designating San Diego as the permanent location of the Cabrillo statue, leaving to the decision jointly of the state park commission and the city council of San Diego as to its location here. **SITE DEDICATED**

That location has been selected and on Dec. 19, last, both the ambassador from Portugal in Washington, J. Antonio de Bianchi, and Euclides Goulart da Costa, the consul of Portugal in San Francisco, have officially approved the location of the Cabrillo statue in San Diego. The site was officially designated by the consul of Portugal on Dec. 19, last.

The assembly of California has never taken any action one way or the other and the introduction of this bill is a definite threat. The city of Oakland, through its park commission, has selected a location for our statue of Cabrillo and the board of supervisors of Alameda county and the city of Oakland have agreed to stand the expense of installation.

AUTHORITY RULING CITED

Being the author of a bill that passed the legislature two years ago, wherein the state of California recognized the 400th anniversary celebration of the discovery of California by Cabrillo, his first landing place being San Diego, our plans are to officially unveil the statue at that time and it seems a pity that Oakland should still be attempting to deprive us of what is rightfully ours.

It is true the governor of California, thinking he had the legal authority, instructed us to ship the Cabrillo statue first to the exposition in San Francisco last spring and later to the city of Oakland. Gov. Olson has no authority, as the attorney general in his legal opinion has determined. So the entire matter lies in the hands of the legislature. I am hoping all those friends interested will write to our three assemblymen and urge that no action be taken by the assembly, and that A. B. 2525 be killed in committee.

An act transferring the possession of the statue of Juan Rodriguez Cabrillo to the City of Oakland

The people of the State of California do enact as follows:

- 1 SECTION 1. The care, custody and control of the statue

Senate Concurrent Resolution No. 7—Relative to advertisement of the San Diego Quadri-centennial Celebration on motor vehicle license plates.

1 WHEREAS, The San Diego-Cabrillo Quadri-centennial Celebration will be held in the city of San Diego in 1942 to celebrate the 400th anniversary of the discovery of California; and

2 WHEREAS, The success of this celebration will be accompanied by increased business and good will for the State, and will call attention to her achievements; and

3 WHEREAS, It is desirable to advertise the celebration and so aid in assuring its success; therefore, be it

4 Resolved by the Senate of the State of California, the Assembly thereof concurring, That the Department of Motor Vehicles is urged and requested to have placed upon the face of all license plates issued for motor vehicles in the year 1942 the following:

5 Cabrillo Centennial San Diego
6 in addition to such matters as is required by law; and be it further

7 Resolved, That copies of this resolution be transmitted to the Department of Motor Vehicles.

Senate Concurrent Resolution No. 2—Relative to the disposition of a statue of John Rodriguez Cabrillo.

1 WHEREAS, John Rodriguez Cabrillo, a native of Portugal, discovered California on Thursday, September 28, 1542, by entering the harbor of San Diego; and

2 WHEREAS, In commemoration of this event the San Diego Cabrillo Quadri-centennial Celebration, to which the Senate and Assembly of California have heretofore by appropriate concurrent resolution requested the Governor to invite the world, will be held in the summer of 1942 at San Diego Bay; and

3 WHEREAS, We are informed that the Republic of Portugal in a gratifying spirit of friendship has donated a statue of John Rodriguez Cabrillo to be erected as a public monument in the State of California; and

4 WHEREAS, We are advised that this statue has been transported to and is now stored in the City and County of San Francisco; now, therefore, be it

5 Resolved by the Senate of the State of California, the Assembly thereof concurring, That it is fitting that this statue of the great explorer be permanently placed near the spot where he made his memorable discovery, wherefore all State officials and other persons having jurisdiction or control over or right to the custody of it are requested and urged to do all things necessary or appropriate, in cooperation with the officials of the City of San Diego and others interested, without cost to the State, to accomplish its placement as a public monument at San Diego, where it may be viewed by all attending the San Diego Quadri-centennial Celebration; and be it further

6 Resolved, That the Secretary of the Senate transmit copies of this resolution to the State Park Commission and to such other State officials and persons as may have or claim a right to the custody of this historic statue.

Our Senator Fletcher is on the job as evidenced by the following article in the San Francisco News, December 20th, last:

"The pint-sized statue of Cabrillo shown at the Exposition was a phony, it turns out, because the real thing — forwarded by the government at Lisbon — is still in the Customs House, where it has been for months and months.

"This discovery has been made by Controller Boyd — a man whose interest in statues hitherto has been less than international. Mr. Boyd was merely helping Senator Ed Fletcher acquire the statue for San Diego. This forced the Controller to establish (1) if there was any such statue, and (2) in that case, who was the man to see.

"After days in which it seemed the statue was as mythical as the Bufano statue of St. Francis — another trial to city officials — Mr. Boyd was able to tell Senator Fletcher that he would have to see a committee of Bay Region Portuguese headed by Dr. J. C. Lopes of Oakland, that he'd have to raise considerable money for a pedestal — and that he'd need a very big truck as the statue weighs six tons."

Senator Fletcher passed legislation at the last session with San Diego as the place to celebrate the 400th Anniversary of the landing of Cabrillo. Los Angeles and San Francisco have been claiming Cabrillo for long these many years, and San Diego is striving to get the statue of Cabrillo permanently located in San Diego.

When interviewed, Senator Fletcher said: "I'm acting on orders from Joe Dryer. Mayor Rossi, Senator Shelley, City Controller Boyd, and many others are co-operating with me in our efforts to have the original Cabrillo statue unveiled in San Diego with proper representation from Portugal, for the Cabrillo 400th Anniversary. The statue had been promised to San Francisco and it is planned to erect it in Golden Gate Park. The chances are against us, but I'm taking the matter up both in Washington and San Francisco, and hoping against hope that we can win."


The matter concerning the final disposal of the Cabrillo statue, which was shown at the Portuguese exhibit at this Exposition, has been very thoroughly investigated.

The statue is the property of the Portuguese Commission to the Golden Gate International Exposition and is under the jurisdiction of the acting Consul General, Mr. Armas do Amaral. I also understand that the local Portuguese colony contributed towards the expenses of participation.

Special representations were made by the Exposition to the Consulate and the Chairman of the Portuguese Association to have the statue sent to San Diego, but were only met with refusal and insistence that it be presented to a local park.

As the Exposition has no rights in the disposal of this exhibit I deeply regret that we can do nothing further in the matter.

Portugal sent to the Golden Gate Exposition a 14 ft. statue of Juan Rodriguez Cabrillo, the discoverer of California on September 28, 1542. He first saw Pt. Loma and landed at San Diego. The statue is made of a beautiful pinkish stone or marble found only in Portugal and weighs nearly ten tons. The statue came in bond and the U.S. Customs amounted to many thousands of dollars. The Exposition authorities did not exhibit the statue but made a dummy. The actual statue remained in storage for many months until the Portuguese Consul in July 1939 offered the statue to the State of California. By so doing, the U.S. customs duty were waived and on July 20, 1939 Governor Culbert L. Olson on behalf of the State of California accepted the gift in the following language:

"I take great pleasure, on behalf of the State of California, in accepting the statue of Cabrillo from the Portuguese Government, and wish to convey to the Department of National Propaganda California's thanks and appreciation of this presentation. It seems to me not only fitting that General Cabrillo's statue should be accepted by California, with assurance of our good will and friendship toward the Portuguese Government, but also for me to acknowledge that the presentation of this statue is a fine gesture of the friendship of Portugal for our state and its people. I might mention that our worthy citizenship is made up in part of thousands of Portuguese people."

Immediately that it was in possession of the State, San Francisco urged it be placed in Golden Gate Park; Sacramento claimed it for the State Capitol grounds in Sacramento, while a large Portuguese delegation headed by Dr. J.C. Lopes of Oakland claimed ownership of the statue. Arrangements were made with the Park Commission of Oakland and the Supervisors to furnish the funds and erect the statue in a public park in Oakland. In the Fall of 1939 San Diego became active in claiming that the statue should come to San Diego for the following reasons:

It was the first landing place of Cabrillo in the discovery of California, and Senator Ed Fletcher of San Diego, representing San Diego County in the State Senate, had introduced and passed during the 1939 Session a bill which the Governor signed recognizing San Diego for the Quadricentennial Celebration on September 28, 1942 in commemoration of Cabrillo's discovery of California. The State of California was authorized to participate in the celebration which will be a notable event lasting many weeks, and the Federal Government and all Foreign nations will be invited to participate in a fitting centennial celebration.

The San Diego Chamber of Commerce instructed Senator Fletcher to bring the statue to San Diego to be dedicated by the Minister from Portugal on September 28, 1942. Senator Fletcher immediately asked and secured cooperation from Mayor Rossi, Senator Shelley and Harold Boyd, City Controller of San Francisco. Mr. Boyd located the statue in a private garage six miles out of San Francisco. Senator Fletcher then introduced a resolution which unanimously passed the Senate approving the location of the statue in San Diego. The Assembly referred it to a committee of three and a strong Oakland delegation appeared before the Committee and action taken by the Committee favorable to Oakland without the author, Senator Fletcher, having an opportunity to be heard. The Oakland-Tribune on February 3rd announced the award of the Assembly Committee to Oakland after the Portuguese Fraternal League had endorsed Oakland as to location.

In the meantime, the Cabrillo Civic Clubs, 48 in number and scattered over the State, became interested and originally supported Sacramento as to location for the statue.

Their State Board of Directors met on February 17th and invited Senator Fletcher to present the matter, with the result that the organization unanimously endorsed San Diego as to location. Oakland officials since then have threatened to go into Court for possession. The State Park Commission of California claimed jurisdiction owing to the fact that the statue was given to the State of California and accepted by Governor Olson.

An investigation develops that the statue has been removed from the private garage and rumor has it that it is on its way to San Diego. When asked where the statue was, Senator Fletcher replied "I have nothing to say."

My dear Dr. Lopes:

Last Saturday morning in discussing the matter with you personally, my understanding was that you claim ownership of the Cabrillo Statue and have definite plans with the money raised for its erection in Oakland - the money coming from the County and the City.

Under these circumstances, of course, San Diego should yield, but on my arrival in Sacramento I find that the State of California really owns the statue, the duty having been waived, and that it is a matter for the Legislature to decide its location. I also find that the Cabrillo Civic Clubs claim certain rights, and under date of January 20th a meeting was being called in connection thereto that the statue be located in Sacramento.

Officially representing the San Diego Chamber of Commerce and the Committee, I offered to reimburse you for the freight which you say you paid from New York to San Francisco, and that offer still holds good. Would you let me know just what the amount is, please, in connection thereto, and if my information is correct that the State of California controls the statue, I hope you will abide by the decision of the State as San Diego will as to the future location of the Cabrillo statue.

Please remember that California and San Diego was first discovered by Cabrillo, also, please remember that our citizenship of Portuguese in San Diego is large, very influential, control the fishing industry and comprise some of our best citizens, also, please remember that the Legislature officially took action last Spring recognizing our 400th Anniversary, and I am enclosing copy of the legislation as passed by the State of California in relation thereto. I hope that you and your Committee can see your way clear to cooperate with us in the

Enclosed find copy of SCR #2 which passed the Senate unanimously.

Somewhere in the Senate an error was made in printing the name "John" instead of "JUAN". Please introduce the amendment and pass the resolution without going to Committee. The facts are these:

Portugal sent a statue of Cabrillo to the San Francisco Exposition last year, the expense of erection was so great as well as the duty, that the Exposition authorities left it in the Customs House and did not erect it. Later through the auspices of the Governor, the statue was given to the State of California - the duty was removed and the statue placed in a private garage in San Francisco. I am enclosing copy of the legislation which I was author of last January re: 400th Cabrillo celebration in 1942. You might state that there has been some talk of placing the statue in Oakland, San Francisco and Sacramento, but San Diego being the first point of discovery by Cabrillo, it is fitting that it should be located in San Diego.

I want this rushed through at the earliest possible moment. The Santa Fe Railway have agreed to haul the statue to San Diego free of cost and the U.S. Navy as well, so Joe Dryer told me. I have sent a copy of this letter to Charlie Stream and Paul Richie asking them to cooperate with you in every way.

Dear Sir:

Regarding repairs to the Cabrillo Statue and its installation at the site heretofore dedicated last December, I recommend the following work:

Install at ground level a concrete slab 8x8 either in diameter or square 2 ft. thick, and in the center thereof a concrete block either 3 ft. high and 4 ft. in diameter, or 4 ft. high and 4 ft. in diameter or square - whichever is most desirable; same to be colored to conform to the Statue, a suggested ochre color.

I will repair the statue in workmanlike manner subject to the approval of Mr. Reginald Poland or any Committee that may be appointed for the purpose.

Total estimate of cost for the improvements and repairs to the Statue, \$750.00.

I will ask the City to furnish some second-hand lumber and necessary material for a temporary building not to exceed 10 or 12 ft. in width and length and approximately 20 ft. high and I will build this temporary building at my own expense.

The City to haul the Statue as is and material to the spot dedicated as a permanent location for the Statue.

I will furnish all equipment, drilling tools, etc. for this work. It will be necessary to do this work by drilling and steel dowel pins - any chips large enough to justify drilling should be drilled and doweled. If any parts are missing, same to be built up in neat cement to match texture of the stone and properly colored.

When the job is completed and accepted, I will tear down the temporary building without expense to the City and clear the place off. If the City wants the second-hand lumber, they will have to come and get it.

It will take approximately three months to do this work right, and I ask for the payment of \$150.00 when the 8x8 ft. slab of concrete is laid 2 ft. thick and paid for by me; \$250.00 when the Statue is erected on the dedicated site, and the balance, i.e. \$350.00 when the work is completed and accepted by the Committee. The entire job to be completed within ninety (90) days from date of delivery of the statue on the ground.


Dear Senator Fletcher:

- a. The approval of this gathering is based on the assumption that the enemy situation will be no worse than at present.
- b. This approval is given with the distinct understanding that this event may be cancelled immediately upon notification, no matter how far plans may have been made for the holding of the same.
- c. That sufficient private guards or auxiliary police are furnished by the sponsor of this gathering to handle traffic and to avoid congestion on the highways.
- d. That a plan is submitted to this headquarters on or before September 1, 1942, setting forth the method provided for the handling of traffic and the precautionary measures taken to avoid highway congestion and for the control of the public.

Dear Colonel Fletcher:

Acting Superintendent Donald Robinson of Cabrillo National Monument has informed me that you are planning a trip to Portugal. While there you will thank the people of Portugal through their President and Premier for the gift to California of the statue of Juan Rodriguez Cabrillo. You also plan to carry special thanks and greetings to Alvaro de Bree, sculptor of the statue. For these purposes, you are carrying and will present resolutions by the City of San Diego and the State of California.

While you are on this mission I will greatly appreciate it if you will assure these officials, the people of Portugal, and Alvaro de Bree, that the National Park Service of the United States Department of the Interior considers it a great honor to have been assigned the custodianship of the Cabrillo statue. We hope that it will ever stand on the grounds of the Cabrillo National Monument which was dedicated, set aside, and named for the great Portuguese navigator by the United States Government.

No doubt they will be interested to know the meaning of the words "National Monument." Please explain that these are areas reserved by the government to preserve objects of prehistoric, historic, and scientific interest of this Country. The landing of Cabrillo in San Diego Bay on Sept. 28, 1542, has been judged one of the significant events in the history of the United States. Therefore, on Oct. 14, 1918, a half acre of land on Point Loma was, by proclamation of President Woodrow Wilson, set aside as the Cabrillo National Monument.

The statue itself came under our jurisdiction on Sept. 28, 1949, the 407th anniversary of the landing. At that time it was dedicated with impressive ceremonies. Among those attending was Dr. Manuel Rocha, an official representative of the government of Portugal. It is well known that the exploration, settlement and development of what is now the United States came about through the efforts of the people of many lands. It is entirely fitting that we have this reminder to our people that a renowned son of Portugal made an important contribution to our history.

Please assure our friends in Portugal that we will protect and preserve the statue and make it available for the benefit and enjoyment of our people. At this monument visitors from not only this Country, but the entire world can come, learn the story of, and pay honor to the great Portuguese mariner, Juan Rodriguez Cabrillo, who discovered California on September 28, 1542.

I sincerely hope that by the time this letter reaches your address, you and Mrs. Fletcher will be back home after enjoying your cruise to the Arctic Circle.


I did not send you the copies of the papers which ought to have published your interview, because Mr. de Brée told me he would take care of that.- I even wonder if your statement has ever been published for, in the meantime, I went to the north and I only came back a few days ago.- Also Mr. Nunes has been absent from the office for a long time owing to ill health and, by the way, he asked me to convey to you and Mrs. Fletcher his best regards.

I would like now to avail of this opportunity to put before you a matter which is of the utmost interest to me.- The office here is now appointing new staffs for all the Portuguese Tourist Bureaux abroad (Casas de Portugal). As a matter of fact they have already appointed them for Paris and London, but New York has been kept in abeyance until August, it seems. The top jobs consist of a General Director and two Assistants, one for Tourism and another for the Commercial Dept.- I was a candidate for one of these posts for New York, but I fear that my hopes are faint. As a matter of fact, a little country like mine is all currents and cross-currents. Practically everybody is related to everybody else, or entangled with everybody else through birth, marriage, friendship, politics, church, hatred, business affiliations, etc.etc., and a man very seldom obtains a fair deal merely through his own merits; generally he gets it only when he is lucky enough to contact the right people.- Under the circumstances, I am practically sure that a nice word of recommendation to our Prime Minister (or to his "second-in-command" the Ministro da Presidencia, Dr. Lumbrals) either from the American highest authorities here or from any other official quarters in the States, would be most helpful to serve my purpose.- Your influence, Senator Fletcher, would be invaluable should you be kind enough to patronize my candidature and do something about this matter.

As you know, I am here in the Public Relations and Reception Dept.(Tourism), but civil servants in this country are so poorly rewarded at home that I anxiously hope that an opportunity will arise soon when I can get some fair job abroad.

Thanks for your letter of July 3 which I find on my desk on our return from our trip to the North Cape and the Midnight Sun.

I am pleased to inform you that I have written direct to His Excellency, Premier Salazar thanking him for the many courtesies that we received from our visit to Portugal, and I definitely mentioned your name and the splendid service you gave us and the fine impression you made on us.

I went the limit, but I want you to treat this letter as confidential. I want to help you in any way I can. I did not mention anything pertaining to appointments, but gave you a strong recommendation. I thought this was for your best interest. If there is anything further that I can do to help you, let me know. If in reply, the Premier mentions you I will keep you posted. And, if you want me to write a separate letter to Dr. Lumbrales, please let me know by airmail.

You will be glad to know that our Ambassador made a special report to the Secretary of State John Foster Dulles of my visit and the reaction of the Portuguese people. The Secretary of State telephoned Senator William Knowland's office the following information which has been conveyed to me, under date of June 22:

"The primary purpose that I want to write to you is to tell that I received a call from the State Department late last week and their primary purpose in calling was to inform us how pleased they were with the meeting that you had with Premier Salazar. He indicated that the meeting had come off very well which, of course, is something you would know so well already. However, they were particularly interested in the after-effect and the fine things which Premier Salazar had to say about the meeting. Apparently, the press made comment on the get-together for several days following, and the general reaction among the Portuguese people was one of great pleasure toward the friendly display of good will from the people of the State of California

as expressed by Senator Fletcher. I thought that you would be pleased to know of the international implications of your visit and the fact that the State Department felt that it is worth so much more than the efforts necessary to arrange the meeting."

I received this letter in Stockholm, Sweden, and it made me very happy. Please do not in any way give this any publicity and treat the whole letter confidential.

I would sure be a pleasure to have you in this country and to see you once in a while. I want you to come to San Diego and let me show you some of our beauty spots, as well.
